1. The terms shall be sold to the highest bidder. The bids are incited for the lot (i.e. all the items contained in the list of old condemned, obsolete office equipment and furniture items as a whole and no bid would be accepted for any part of the same.
2. The Earnest Money Deposit(EMD) of successful bidder shall be adjusted from the total payment.
3. The successful bidder has to make full balance payment, after due adjustment of the EMD, in the form of Demand Draft in favor of "IITTM, Bhubaneswar within three days after confirmation, failing which the offer will be cancelled and the EMD shall stand forfeited. The EMD of unsuccessful bidders shall be returned within one month after the auction whatsoever.
4. No item once disposed the successful bidder shall be taken back by this office on any condition whatsoever.
5. The successful bidder will be required to lift all items from the disposal site within three days after the payment of the balance amount. On failure to do so this office shall have the right to forfeit the entire amount of the bidder and dispose the items to make alternate bidder. The successful bidder, of their own cost, will also be required to make their own arrangement of transport, Labour etc. for lifting the disposed items.
